Entry and departure requirements – travel update

Travelers arriving in Greece should have a negative PCR test certificate, having been tested no more than 72 hours before arrival. In the case that a traveller is vaccinated, and 14 days have elapsed since the last dose required for the particular vaccination to be complete, then proof of a negative test is not required. The Greek government has announced that arrivals from the following countries are exempt from the need to self-isolate upon arrival in Greece should they meet the aforementioned criteria: EU & Schengen Area countries, USA, UK, Israel, Serbia, UAE, New Zealand, Australia, South Korea, Thailand, Rwanda, Singapore, and the Russian Federation. All inbound travelers must complete their PLF the day before entering the country, providing detailed information on their point of departure, previous stays in other countries, and the address of their stay while in Greece.

CERTIFICATION

We have been certified with the “HEALTH FIRST” from the Ministry of Tourism.

TRAINING

Each one of us has been officially trained for all health and management protocols related to COVID-19. We are knowledgeable of:

- The ways of which the virus is transmitted.
- Behavior and actions needed to be taken in case of illness.
- Methods and practices of cleaning and disinfecting frequently touched surfaces leading to the possibility of transmitting the disease.
- Communication approaches to visitors/customers.
- Maintaining the necessary protocols in order to avoid transmission of the virus by thorough and regular hand washing, avoiding handshakes, keeping distances, avoiding contact of hands on the eyes, nose and mouth, using surgical masks.

ACTION PLAN

We have drawn up an Action plan for suspected cases.

Specifically, for the handling of a suspected case following the plan for dealing with a suspected case from National Organization for Public Health.

To ensure the implementation of the accommodation’s suspected case handling plan is followed.

The accommodations are obligated to share contact details to the according services of the Ministry of Health (National Organization for Public Health):

The owner of Parea Kalamitsi is in charge of implementing the action plan for suspected cases.

ACCOMMODATION FILE AND EVENT BOOK

For the purposes of public health protection, the accommodation must keep a record of staff members and all people staying at Parea Kalamitsi including their:- name, nationality, date of arrival and departure, contact details (address, telephone, e-mail) - , so that we can communicate with each one in the case of any COVID-19 incident.

ARRIVAL AND DEPARTURE

- Check in: After 15:00 PM
- Check out: BY 11:00 AM

HOUSES

- Cleaning and disinfection program (according to the current instructions of National Organization for Public Health).
- Thorough cleaning of the house prior to checking in.
- Disinfection with steam cleaner and certified disinfecting cleaning agents for all surfaces.
- Meticulous cleaning and appropriate ventilation before arrivals.
- Non-regular cleaning during the accommodation in order to avoid unnecessary contact and further transmission. Upon request we will clean your house on the fourth day and thereafter with no visitors inside the house.
- Linen and towels will be replaced on the fourth day and thereafter, unless the customer requests otherwise.
- Opening doors and windows for natural ventilation of the space daily is required from our guests.
- Antiseptic liquids will be available in common outdoor areas.
- Special instructions for cleaning in case of a confirmed case (according to the current instructions of National Organization for Public Health).
- Prohibition of entry in the apartments for non-residents.

AIR CONDITIONING

- A/C cleaning and disinfection has been performed by a certified provider.
- The use of air conditioning is not allowed when guests are absent from the house.
- A/C use is recommended for use only if the outside temperature is more than 39 degrees.
- The recommended operating temperature for air conditioning is 26 degrees C, 79 degrees F. and to no less than 23/73 degrees. The fan scale should be at 75%.
- When the air conditioner is turned on, there must be an open window, for recirculation of air and natural ventilation.
